IV. Partner Reports/Updates

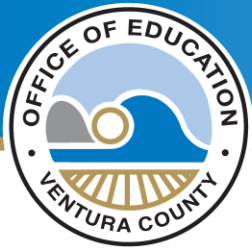
- District Attorney's Office – Ms. Byrne stated that the courts are fully opened and the SARB calendars are being set.
